ORDINANCE NO. 2013-12

AN ORDINANCE TO AMEND AND RE-ENACT THE SCHEDULE OF FEES TO ADD A PERMIT FEE FOR REPAIR OR REPLACEMENT OR REPAIR OF METER PAN, RISER PIPE AND/OR WEATHERHEAD AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the City of Central Council enacted Ordinance Nos. 2010-10 and 2011-13 adopting a Schedule of Fees for Additional Permit Fees;

WHEREAS, upon the recommendation of City Services, the City of Central Council desires to include certain permits within the list of enumerated Additional Permit Fees;

BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. The Council hereby amends and re-enacts fees previously enacted in Ordinance Nos. 2010-10 and 2011-13 by adding the items listed herein.

| <u>Meter pan/components (i.e. socket, riser pipe and/or weatherhead repair or replacement when the main electrical panel is not replaced.</u> | <u>\$30</u> |

Section 2. Conflicts

This Ordinance and Schedule of Fees shall supersede any and all other fees for the items included herein. Any fee not amended by this Ordinance shall remain in effect. All ordinances or part of ordinances in conflict with this Ordinance and Schedule of Fees are hereby repealed.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of the invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Schedule of Fees shall become effective on June 1, 2013.






