ORDINANCE NO. 2013-13

TO AMEND THE 2012-2013 FISCAL YEAR HALF-CENT SALES TAX BUDGET TO APPROPRIATE FUNDS FOR PREPARATION OF BID SPECIFICATIONS AND ADVERTISING FOR THE 2013 ROAD MAINTENANCE AND REHABILITATION PROGRAM AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, in order for Professional Engineering Consultants Corporation (“PEC”) to obtain bids from contractors for the 2013 Road Maintenance and Rehabilitation Program, it is necessary for PEC to prepare bid specifications and place advertisements in the Official Journal; and

WHEREAS, preparation of bid specifications and publication of advertisements in the Official Journal for the 2013 Road Maintenance and Rehabilitation Program is estimated at \$30,000;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1: The Council for the City of Central hereby amends Ordinance No. 2012-06 adopting the 2012-2013 Fiscal Year Budget for the Half-Cent Sales Tax Fund (East Baton Rouge Parish Green Light Roadway Fund) to appropriate \$40,000 to be designated as Account Number 120.431.11.730 for the preparation of bid specifications and advertisements in the Official Journal for the 2013 Road Maintenance and Rehabilitation Program.

Section 2: Conflicts

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 3: Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4: Effective Date

This Ordinance shall be effective upon publication.




