**ORDINANCE NO. 2013-04**

**TO AMEND THE 2012-2013 FISCAL YEAR GENERAL  
FUND BUDGET TO APPROPRIATE ADDITIONAL FUNDS  
FOR NOTIFICATIONS AND TO PROVIDE FOR RELATED  
MATTERS**

WHEREAS, La R.S. 33:406(B)(2) requires “[a]fter a proposed ordinance has been introduced . . . [t]he title of a proposed ordinance, except those specifically authorized by R.S. 33:405(D), shall be published once in the municipality's official journal”; and

WHEREAS, La. R.S. 33:406(D)(2) requires “[t]he municipal clerk shall publish each ordinance adopted by the board of aldermen once in the official journal of the municipality, designated pursuant to R.S. 43:141 through R.S. 43:149, within twenty days of its adoption and prior to its effective date, except as otherwise provided in R.S. 33:405(D)”; and

WHEREAS, La. R.S. 42:19(2)(a) requires the Council for the City of Central to provide written public notice of the agenda for its regular meetings “. . . by publication of the notice in an official journal of the public body no less than twenty-four hours before the meeting”; and

WHEREAS, the costs for publishing agenda, titles of proposed ordinances, minutes of council meetings, and adopted ordinances, as required by state law, in the official journal are funded from the 2012-2013 Fiscal Year General Fund Budget Account No. 000.411.30.540 for Legislative Notifications (“FY 2012-2013 Notifications Budget”); and

WHEREAS, the City of Central also publishes requests for qualifications and proposals in its official journal; and

WHEREAS, on June 12, 2012 the Council for the City of Central adopted Ordinance No. 2012-06 appropriating \$6,000.00 for the FY 2012-2013 Notifications Budget; and

WHEREAS, the \$6,000.00 appropriated for the FY 2012-2013 Notifications Budget is insufficient to publish agendas, titles of proposed ordinances, minutes of council meetings, adopted ordinances and requests for qualifications and proposals for the City of Central, as required by state law, for the remainder of the 2012-2013 fiscal year; and

WHEREAS, the Council for the City of Central desires to appropriate additional funds for the FY 2012-2013 Notifications Budget;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1:** The Council for the City of Central hereby amends Ordinance No. 2012-06 adopting the 2012-2013 Fiscal Year General Fund Budget for the City of Central as amended by Ordinance Nos. 2012-13, 2012-14 and 2012-20 to appropriate an additional \$9,000.00 for Legislative Notifications designated as Account No. 000.411.30.540 for the purpose of publishing agendas, titles of proposed ordinances, minutes of council meetings, adopted ordinances and requests for qualifications and proposals for the City of Central, as required by state law, for the remainder of the 2012-2013 fiscal year.

**Section 2: Conflicts**

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**Section 3: Effective Date**

This Ordinance shall be effective upon publication.






