**ORDINANCE NO. 2013-5**

**TO AMEND THE 2012-2013 FISCAL YEAR GENERAL  
FUND BUDGET TO APPROPRIATE ADDITIONAL FUNDS  
FOR PLANNING AND ZONING LEGAL SERVICES AND  
TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the Mayor and Council of the City of Central desire to have continued legal counsel for planning and zoning matters through the 2012-2013 Fiscal Year, including but not limited to, advising at City of Central Planning and Zoning Commission meetings, preparing zoning ordinances, and representing the City in any legal matter related to planning and zoning which may arise during the remainder of the 2012-2013 Fiscal Year; and

WHEREAS, Ordinance No. 2012-06 enacting the Operating Budget for the 2012-2013 Fiscal Year included an appropriation of \$38,000.00 for Planning & Zoning Account No. 000.418.45.330 for Legal Services; and

WHEREAS, due to the amount of work relative to the proposed comprehensive revisions the City of Central's current Zoning Ordinances during the 2012-2013 Fiscal Year and the amount of work needed to complete the comprehensive revisions to the City of Central's Zoning Ordinances it is necessary to increase the 2012-2013 Fiscal Year appropriation for Planning & Zoning Legal Services by \$14,000.00; and

WHEREAS, the Council for the City of Central desires to appropriate additional funds for the 2012-2013 Fiscal Year Planning & Zoning Legal Services Budget;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1:** The Council for the City of Central hereby amends Ordinance No. 2012-06 adopting the 2012-2013 Fiscal Year General Fund Budget for the City of Central as amended by Ordinance Nos. 2012-13, 2012-14, 2012-20 to appropriate an additional \$14,000.00 for Planning & Zoning Legal Services designated as Account No. 000.418.45.330 for the purpose of providing continued legal services to the City of Central relative to planning and zoning matters.

**Section 2: Conflicts**

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**Section 3: Effective Date**

This Ordinance shall be effective upon publication.




