ORDINANCE NO. 2014-19

**AN ORDINANCE TO AMEND THE 2014-2015 FISCAL YEAR BUDGET TO APPROPRIATE ADDITIONAL FUNDS FOR OPERATIONAL PURPOSES FOR THE POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the Council for the City of Central did not include funds for the City of Central Police Department for the purpose of employing a full time assistant to the chief of police or funds to increase the size of the present City of Central Police Department Office Space in the 2014-2015 Fiscal General Fund Budget;

WHEREAS, the Council for the City of Central recognizes that the Police Chief desires to hire an Assistant Chief to provide additional full time support and assist with administration of the City of Central Police Department.

WHEREAS, the Council for the City of Central recognizes that the Police Chief is anticipating the need for a larger office space to house the City of Central Police Department and as a result expects an increase in monthly rental fees and utilities.

WHEREAS, the Council for the City of Central desires to amend the 2014-2015 Fiscal Year General Budget to appropriate funds necessary related to the above stated matters.

BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1:** Account No. 000.421.20.110 is hereby created to properly account for salary and/or wages for employees of the City of Central Police Department and is hereby increased to \$41,600 to provide for wages to be paid to an Assistant Police Chief.

**Section 2:** Account No. 000.421.05.111 is hereby increased by \$1,246.04 to provide for the increase in additional payroll taxes related to hiring of an Assistant Chief.

**Section 3:** Account No. 000.421.05.260 is hereby increased by \$936.59 to provide for the increase in additional worker's compensation insurance premiums related to hiring an Assistant Chief.

**Section 4:** Account No. 000.421.05.441 is hereby increased by \$9,600 to cover the additional rent expected by moving the City of Central Police Department from its current Suite 7 to Suite 6 in order to increase the office space for the department.

**Section 5:** Account No. 000.421.05.410 is hereby increased by \$3,600 to cover the additional costs of utilities related to the increase of office space occupied by the City of Central Police Department.

**Section 6: Conflicts**

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**Section 7: Severability**

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 8: Effective Date**

This Ordinance shall be effective upon publication.


