**ORDINANCE NO. 2014-33**

**AN ORDINANCE TO AMEND 2014-2015 FISCAL YEAR BUDGET TO PROPERLY ACCOUNT FOR CRASH REPORT FEES COLLECTED BY THE CENTRAL POLICE DEPARTMENT AND TO PROVIDE FOR RELATED MATTERS**

WHEREAS, the Council for the City of Central did not include revenues for the collection of Crash Report Fee Revenues by the Central Police Department in the 2014-15 Fiscal Year General Budget; and

WHEREAS, the Council for the City of Central wishes to segregate these revenues from other miscellaneous General Fund Revenues;

WHEREAS, the Council for the City of Central desires to amend the 2014-2015 Fiscal Year General Budget to properly account for the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

**Section 1.** Crash Report Fees (Account No. 000.342.10) is hereby created and increased by \$6,500.00 to provide for estimated collections of Crash Report Fees by the Central Police Department for the remainder of the 2014-15 Fiscal Year.

**Section 2. Conflicts**

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

**Section 3. Severability**

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 4. Effective Date**

This Ordinance shall be effective upon publication.




