3 **PROPOSED ORDINANCE NO. 2014-\_\_\_\_\_**

5 **AN ORDINANCE TO AMEND THE 2014-2015 FISCAL YEAR BUDGET**  
6 **TO APPROPRIATE ADDITIONAL FUNDS FOR OPERATIONAL**  
7 **PURPOSES FOR THE POLICE DEPARTMENT AND TO PROVIDE FOR**  
8 **RELATED MATTERS**

10 WHEREAS, the Council for the City of Central did not include funds for the City of  
11 Central Police Department for the purpose of employing a full time assistant to the chief of  
12 police or funds to increase the size of the present City of Central Police Department Office Space  
13 in the 2014-2015 Fiscal General Fund Budget;

14  
15 WHEREAS, the Council for the City of Central recognizes that the Police Chief desires  
16 to hire an Assistant Chief to provide additional full time support and assist with administration of  
17 the City of Central Police Department.

18  
19 WHEREAS, the Council for the City of Central recognizes that the Police Chief is  
20 anticipating the need for a larger office space to house the City of Central Police Department and  
21 as a result expects an increase in monthly rental fees and utilities.

22  
23 WHEREAS, the Council for the City of Central desires to amend the 2014-2015 Fiscal  
24 Year General Budget to appropriate funds necessary related to the above stated matters.

26 BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

27  
28 **Section 1:** Account No. 000.421.20.110 is hereby created to properly account for salary  
29 and/or wages for employees of the City of Central Police Department and is hereby increased to  
30 \$41,600 to provide for wages to be paid to an Assistant Police Chief.

31  
32 **Section 2:** Account No. 000.421.05.111 is hereby increased by \$1,246.04 to provide for the  
33 increase in additional payroll taxes related to hiring of an Assistant Chief.

34  
35 **Section 3:** Account No. 000.421.05.260 is hereby increased by \$936.59 to provide for the  
36 increase in additional worker's compensation insurance premiums related to hiring an Assistant  
37 Chief.

39 **Section 4:** Account No. 000.421.05.441 is hereby increased by \$9,600 to cover the additional  
40 rent expected by moving the City of Central Police Department from its current Suite 7 to Suite 6  
41 in order to increase the office space for the department.

42  
43 **Section 5:** Account No. 000.421.05.410 is hereby increased by \$3,600 to cover the additional  
44 costs of utilities related to the increase of office space occupied by the City of Central Police  
45 Department.

The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

**Section 8: Effective Date**
