ORDINANCE NO. 2015 -27

AN ORDINANCE ENACTING THE GENERAL FUND BUDGET AND THE DEDICATED FUND BUDGETS FOR THE EMERGENCY SERVICES, DRAINAGE, AND LOCAL ROAD IMPROVEMENT & MAINTENANCE FUND FEES, THE HALF CENT SALES AND USE TAX AND THE TRAFFIC CONTRIBUTION FUNDS FOR THE 2015-2016 FISCAL YEAR AND PROVIDING FOR RELATED MATTERS

WHEREAS, I. M. Shelton, Jr., in his capacity as Mayor of the City of Central, prepared the proposed General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fee, the Half Cent Sales and Use Tax and the Traffic Contribution Funds for the fiscal year beginning July 1, 2015 and ending June 30, 2016; and

WHEREAS, the proposed General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees, the Half Cent Sales and Use Tax and the Traffic Contribution Funds were submitted to this City Council for review and consideration prior to introduction; and

WHEREAS, notice of a public hearing on the proposed General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees, the Half Cent Sales and Use Tax and the Traffic Contribution Funds were timely published in the Advocate; and

WHEREAS, a public hearing on the proposed General Fund Budget and the Dedicated Fund Budgets for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees, the Half Cent Sales and Use Tax and the Traffic Contribution Funds was conducted;

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana:

Section 1. General Fund. The General Fund Budget for the 2015-2016 Fiscal Year is hereby adopted as shown in Exhibit A – City of Central Budget 2015-16 attached hereto.

Section 2. Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fee. The Dedicated Fund Budget for the Emergency Services, Drainage, and Local Road Improvement & Maintenance Fund Fees for the 2015-2016 Fiscal Year as shown in Exhibit A – City of Central Budget 2015-16 attached here is hereby adopted.

Section 3. Half-Cent Sales and Use Tax. The Dedicated Fund Budget for the Half Cent Sales and Use Tax for the 2015-2016 Fiscal Year as shown in Exhibit A – City of Central Budget 2015-16 attached hereto is hereby adopted.

Section 4. Traffic Contribution. The Dedicated Fund Budget for the Traffic Contribution for the 2015-2016 Fiscal Year as shown in Exhibit A – City of Central Budget 2015-16 attached hereto is hereby adopted.

Section 5. Severability. If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 6. Conflicts. All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 7. Effective Date. This Ordinance shall be effective on July 1, 2015.


