ORDINANCE NO. 2015-45

AN ORDINANCE TO AMEND THE 2015-2016 FISCAL YEAR EMERGENCY SERVICES, DRAINAGE & LOCAL ROAD IMPROVEMENT & MAINTENANCE FUND BUDGET TO APPROPRIATE FUNDS FOR THE DESIGN OF THE FRENCHTOWN ROAD CULVERT REPAIR PROJECT AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, approximately 2,200 linear feet north of the railroad crossing at Frenchtown Road portions of the roadway near a cross drain have become a safety hazard to the motoring public;

WHEREAS, in order to keep the road open in the future repairs are needed to the roadway and cross drain;

WHEREAS, the Council agrees that due to the existing conditions of the roadway that this street necessitates repair as soon as possible;

WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal Year Emergency Services, Drainage & Local Road Improvement & Maintenance Fund Budget to properly appropriate necessary funds related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Road Repair/Maintenance (Emergency Services, Drainage & Local Road Improvement & Maintenance Fund Account No. 110.431.10.000) is hereby increased by \$5,700.00 to provide for the expenditures related to the roadway design services for the Frenchtown Road Culvert Repair Project and related improvements.

Section 2. Conflicts

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Ordinance shall be effective upon publication.




