7 AN ORDINANCE TO AMEND THE 2015-2016 FISCAL
8 YEAR EMERGENCY SERVICES, DRAINAGE & LOCAL
9 ROAD IMPROVEMENT & MAINTENANCE FUND
10 BUDGET TO APPROPRIATE FUNDS FOR THE DESIGN OF
11 THE FRENCHTOWN ROAD CULVERT REPAIR PROJECT
12 AND TO PROVIDE FOR RELATED MATTERS

13
14 WHEREAS, approximately 2,200 linear feet north of the railroad crossing at Frenchtown
15 Road portions of the roadway near a cross drain have become a safety hazard to the motoring
16 public;

17
18 WHEREAS, in order to keep the road open in the future repairs are needed to the roadway
19 and cross drain;

20
21 WHEREAS, the Council agrees that due to the existing conditions of the roadway that this
22 street necessitates repair as soon as possible;

23
24 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal
25 Year Emergency Services, Drainage & Local Road Improvement & Maintenance Fund Budget to
26 properly appropriate necessary funds related to the above stated matters.

28 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
29 Louisiana as follows:

31 **Section 1.** Road Repair/Maintenance (Emergency Services, Drainage & Local Road
32 Improvement & Maintenance Fund Account No. 110.431.10.000) is hereby increased by
33 \$5,700.00 to provide for the expenditures related to the roadway design services for the
34 Frenchtown Road Culvert Repair Project and related improvements.

36 **Section 2. Conflicts**

38 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

40 **Section 3. Severability**

42 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
43 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
44 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of
45 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
46 effect.
