7 AN ORDINANCE TO AMEND THE 2015-2016 FISCAL  
8 YEAR EMERGENCY SERVICES, DRAINAGE, & LOCAL  
9 ROAD IMPROVEMENT & MAINTENANCE FUND  
10 BUDGET TO APPROPRIATE FUNDS FOR THE DESIGN OF  
11 THE HEARTHWOOD DRIVE ROAD IMPROVEMENT  
12 PROJECT AND TO PROVIDE FOR RELATED MATTERS

14 WHEREAS, the City has received numerous complaints and has made some minor  
15 emergency patching repairs to Hearthwood Drive;

16  
17 WHEREAS, Hearthwood Drive is currently unpaved in some portions and the roadway  
18 base has completely failed throughout the roadway;

19  
20 WHEREAS, the Council agrees that due to the existing conditions of the roadway that this  
21 street necessitates repaving as soon as possible with a new asphaltic concrete overlay and soil  
22 cement base;

23  
24 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal  
25 Year Emergency Services, Drainage, & Local Road Improvement & Maintenance Fund Budget to  
26 properly appropriate necessary funds related to the above stated matters.

27  
28 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of  
29 Louisiana as follows:

30  
31 **Section 1:** Road Repair/Maintenance (Emergency Services, Drainage & Local Road  
32 Improvement & Maintenance Fund Account No. 110.431.10.000) is hereby increased by  
33 \$12,650.00 to provide for the expenditures related to the roadway design services for the  
34 Hearthwood Drive improvements.

36 **Section 2. Conflicts:** All ordinances or parts of ordinances in conflict with this Ordinance are  
37 hereby repealed.

39 **Section 3. Severability:** If any section, subsection, sentence, clause or provision of this  
40 Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of  
41 invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the  
42 part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of  
43 invalidity and shall remain in force and effect.

45 **Section 4. Effective Date:** This Ordinance shall be effective upon publication.
