5 TO AMEND AND REENACT APPENDIX G, PART I, SECTION 107, OF  
6 THE CODE OF ORDINANCES OF THE CITY OF CENTRAL TO  
7 PROVIDE FOR VARIANCES RELATIVE TO DESIGN STANDARDS IN  
8 OVERLAY DISTRICTS AND TO PROVIDE FOR ALL RELATED  
9 MATTERS

11 WHEREAS, the Council of the City of Central desires to amend its ordinances relative to  
12 variances of Design Standards in Overlay Districts to make it consistent with La. R.S. 33:4727;

13  
14 BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

15  
16 **Section 1:** Appendix G, Part I, Section 107 of the Code of Ordinances of the City of Central  
17 as enacted by Ordinance No. 2013-22 is hereby amended and re-enacted, so as to read as  
18 follows:

20 Appendix G. Design Standards in Overlay Districts

21  
22 Part I. In General

23  
24 Section 107. Variance

25  
26 A temporary or permanent variance from one of more of the requirements set forth in the  
27 Overlay Design Standards may be granted by the Council after recommendation by the  
28 ~~Construction Board of Appeals~~ Board of Adjustment where the property owner  
29 demonstrates that the compliance with one or more design standard would result in a  
30 particular hardship upon the owner as distinguished from a mere inconvenience and the  
31 granting of the variance will not diminish the desired character or value of the property  
32 within the area.

33  
34 **Section 2: Conflicts**

35 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

36  
37 **Section 3: Severability**

38  
39 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court  
40 of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity  
41 of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder  
42 of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force  
43 and effect.

45 **Section 4: Effective Date**

1 This Ordinance shall be effective upon publication.
