PROPOSED ORDINANCE NO. 2015-__

AN ORDINANCE TO AMEND THE 2014-2015 FISCAL
YEAR GENERAL BUDGET TO APPROPRIATE FUNDS
FOR SURVEYING, DESIGN AND ENGINEERING PLANS
FOR VARIOUS ROAD CONSTRUCTION PROJECTS

WHEREAS, the Administration for the City of Central desires to make necessary roadway improvements to Frenchtown Road (Greenwell Springs to Central Thruway); the Frenchtown Road at Planchet Road intersection; and the Denham Road at Hubbs Road intersection.

WHEREAS, the Council for the City of Central desires to amend the 2014-15 Fiscal Year General Budget to appropriate funds necessary for surveying, design, and engineering.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Account No. 120.431.10.730 is hereby increased by \$77,000.00 to provide for the surveying of Frenchtown Road (Greenwell Springs Road to Central Thruway); design and engineering services for the Frenchtown Road improvements (Greenwell Springs Road to Central Thruway); and design and engineering services for the Denham Road at Hubbs Road intersection improvements.

Section 2. Account No. 431.60.000 (Storm/Street Drainage) is hereby increased by \$25,000 to provide for the design and engineering services for the Frenchtown Road at Planchet Road intersection improvements.

Section 3. Conflicts

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 4. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.
