ORDINANCE NO. 2016-37

AN ORDINANCE TO AMEND THE 2016-2017 FISCAL YEAR GENERAL FUND BUDGET TO APPROPRIATE FUNDS FOR INSURANCE EXPENDITURES FOR CITY OF CENTRAL AND TO PROVIDE FOR RELATED MATTERS

WHEREAS, the Council for the City of Central included Insurance expenditures in the General Fund budget for 2016-17 based on estimated figures;

WHEREAS, the City of Central Insurance expenditures have been determined to be more than originally budgeted and

WHEREAS, the Council for the City of Central desires to amend the 2016-2017 General Fund Budgets to properly appropriate funds necessary related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Insurance-Worker's Comp (Account No. 000.419.70.260 General Fund) is hereby increased by \$110.00 for expenditures related to worker's compensation insurance for the City of Central.

Section 2. Insurance-General Liability (Account No. 000.419.70.520 General Fund) is hereby increased by \$4,300.00 for expenditures related to general liability insurance for the City of Central.

Section 3. Insurance-Worker's Comp (Account No. 000.421.05.260 General Fund) is hereby increased by \$45.00 for expenditures related to worker's compensation insurance for the City of Central Police Department.

Section 4. Conflicts

The specific terms and conditions of this Ordinance shall prevail against prior ordinances of the City to the extent that there may be any conflict.

Section 5. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 6. Effective Date

This Ordinance shall be effective upon publication.




