7 AN ORDINANCE TO AMEND THE 2015-2016 HALF CENT
8 FUND FISCAL YEAR BUDGET TO APPROPRIATE
9 ADDITIONAL FUNDS FOR INTERSECTION
10 IMPROVEMENTS FOR THE DENHAM ROAD & HUBBS
11 ROAD INTERSECTION AND TO PROVIDE FOR RELATED
12 MATTERS

14 WHEREAS, the Council and the Mayor of the City of Central desires to make necessary
15 roadway improvements at the Denham Road and Hubbs Road intersection; and

16
17 WHEREAS, Professional Engineering Consultants Corp had estimated the construction
18 costs to be \$30,000 for the roadway improvements at the Denham Road and Hubbs Road
19 intersection;

21 WHEREAS, the actual costs of the construction is \$31,200 and as a result, the Council did
22 not include adequate funding for the construction phase of this project within the Half Cent Fund
23 in the 2015-16 Budget;

25 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal
26 Year Half Cent Budget to properly appropriate necessary funds related to the above stated matters.

28 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
29 Louisiana as follows:

31 **Section 1.** Construction (Half Cent Fund Account No. 120.431.10.730) is hereby increased by
32 \$1,200.00 to provide for the expenditures related to the construction costs of the intersection
33 improvements at Denham Road and Hubbs Road.

35 **Section 2. Conflicts**

37 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

39 **Section 3. Severability**

41 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
42 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
43 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of
44 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
45 effect.
