7 AN ORDINANCE TO AMEND THE 2015-2016 FISCAL
8 YEAR BUDGET TO APPROPRIATE FUNDS FOR THE
9 RECEIPT OF A DONATION OF A CARGO TRAILER FOR
10 THE POLICE DEPARTMENT AND TO PROVIDE FOR
11 RELATED MATTERS

13 WHEREAS, the Council for the City of Central did not include within the 2015-16 Fiscal
14 Year General Budget for the City of Central Police Department, receipt of a donation for a 2007
15 Wells Cargo Trailer by the City of Central Police Department; and

17 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal
18 Year General Budget to properly appropriate funds necessary related to the above stated matters.

20 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
21 Louisiana as follows:

23 **Section 1.** Equipment-PD (Account No. 000.421.05.741) is hereby increased by \$2500 to
24 provide for the donated 2007 Wells Cargo Trailer for the City of Central Police Department.

26 **Section 2.** Donations-PD (Account No. 000.364.20) is hereby increased by \$2500 for the
27 donation received related to the 2007 Wells Cargo Trailer by the City of Central Police
28 Department.

30 **Section 3. Conflicts**

32 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

34 **Section 4. Severability**

36 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
37 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
38 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of
39 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
40 effect.
