5 PROPOSED ORDINANCE NO. 2016-___

7 AN ORDINANCE TO AMEND THE 2015-2016 FISCAL
8 YEAR BUDGET TO APPROPRIATE FUNDS FOR
9 UNIFORMS AND TO ACCOUNT FOR A REDUCTION IN
10 VESTS FOR THE POLICE DEPARTMENT AND TO
11 PROVIDE FOR RELATED MATTERS

13 WHEREAS, the Council for the City of Central included funds in Vests for purchase of
14 body armor vests in the 2015-16 Fiscal Year General Fund Budget for the City of Central Police
15 Department; and

16
17 WHEREAS, the Council for the City of Central recognizes that adequate funds for
18 Uniforms were not provided in the 2015-16 Fiscal Year General Fund Budget for the City of
19 Central Police Department;

20
21 WHEREAS, the Council for the City of Central wishes to reduce the funds allocated to
22 Vests and reallocate those funds to Uniforms within the Central Police Department;

23
24 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal
25 Year General Budget to properly appropriate necessary funds related to the above-stated matters.

27 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
28 Louisiana as follows:

30 **Section 1.** Uniforms (General Fund Account No. 000.421.20.800) is hereby increased by
31 \$2,800.00 to provide for expenditures related to uniform expenditures for the City of Central Police
32 Department.

33
34 **Section 2.** Vests (General Fund Account No. 000.421.25.800) is hereby decreased by
35 \$2,800.00 so that additional funds related to uniforms can be provided for the City of Central
36 Police Department.

38 **Section 3. Conflicts**

40 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

42 **Section 4. Severability**

44 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
45 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
46 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

1 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
2 effect.
