7 AN ORDINANCE TO AMEND THE 2016-2017 FISCAL
8 YEAR BUDGET TO APPROPRIATE FUNDS FOR THE
9 RECEIPT OF DONATIONS AND EXPENDITURES FOR
10 THE BIRTHDAY BASH AND TO PROVIDE FOR RELATED
11 MATTERS

13 WHEREAS, the Council for the City of Central did not include within the 2016-17 Fiscal
14 Year General Budget for the City of Central, receipt of a donations by cash and in-kind for the
15 Birthday Bash Community Event; and

16
17 WHEREAS, the Council for the City of Central did not include all expenditures related to
18 the Birthday Bash Community Event within the 2016-17 Fiscal Year General Budget for the City
19 of Central; and

21 WHEREAS, the Council for the City of Central desires to amend the 2016-2017 Fiscal
22 Year General Budget to properly appropriate funds necessary related to the above stated matters.

24 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
25 Louisiana as follows:

27 **Section 1.** Community Events (Account No. 000.464.40.000) is hereby increased by
28 \$29,916.74 to provide for the additional expenditures of holding the Birthday Bash Community
29 Event.

31 **Section 2.** Donations-City (Account No. 000.364.10) is hereby increased by \$29,699.83 for
32 the donations received in cash and in-kind related to Birthday Bash Community Event.

34 **Section 3. Conflicts**

36 The specific terms and conditions of this Ordinance shall prevail against other ordinances of the
37 City to the extent that there may be any conflict.

40 **Section 4. Severability**

42 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of
43 competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of
44 the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of
45 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
46 effect.
