PROPOSED ORDINANCE NO. 2016-__

AN ORDINANCE TO AMEND THE 2015-2016 FISCAL
YEAR EMERGENCY SERVICES, DRAINAGE, & LOCAL
ROAD IMPROVEMENT & MAINTENANCE FUND
BUDGET TO APPROPRIATE FUNDS FOR THE
CONSTRUCTION OF THE HEARTHWOOD DRIVE ROAD
IMPROVEMENT PROJECT AND TO PROVIDE FOR
RELATED MATTERS

WHEREAS, the City has received numerous complaints and has made some minor emergency patching repairs to Hearthwood Drive;

WHEREAS, Hearthwood Drive is currently unpaved in some portions and the roadway base has completely failed throughout the roadway;

WHEREAS, the Council agrees that due to the existing conditions of the roadway that this street necessitates repaving as soon as possible with a new asphaltic concrete overlay and soil cement base;

WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal Year Emergency Services, Drainage, & Local Road Improvement & Maintenance Fund Budget to properly appropriate necessary funds related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Road Repair/Maintenance (Emergency Services, Drainage & Local Road Improvement & Maintenance Fund Account No. 110.431.10.000) is hereby increased by \$69,250.00 to provide for the expenditures related to the roadway construction for the Hearthwood Drive improvements.

Section 2. Conflicts

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of

1 the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and
2 effect.
