7 AN ORDINANCE TO AMEND THE 2015-2016 FISCAL
8 YEAR BUDGET TO APPROPRIATE FUNDS FOR
9 TRAINING FOR THE P & Z COMMISSION MEMBERS
10 AND COUNCIL MEMBERS AND TO PROVIDE FOR
11 RELATED MATTERS

13 WHEREAS, the Council for the City of Central wishes to provide training for the P & Z
14 Commission Members and Council Members; and

16 WHEREAS, the Council for the City of Central recognizes that funds for training for this
17 purpose were not provided in the 2015-16 Fiscal Year General Fund Budget;

19 WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal
20 Year General Budget to appropriate necessary funds related to the above-stated matters.

22 NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of
23 Louisiana as follows:

25 **Section 1.** Education & Conferences (General Fund Account No. 000.418.20.270) is hereby
26 created and increased by \$4,000.00 to provide for expenditures related to training expenditures
27 for the P & Z Commission Members and Council Members.

29 **Section 2. Conflicts**

31 All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

33 **Section 3. Severability**

35 If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court
36 of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity
37 of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder
38 of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force
39 and effect.
