PROPOSED ORDINANCE NO. 2016-__

**AN ORDINANCE TO AMEND THE 2015-2016 HALF CENT
FUND FISCAL YEAR BUDGET TO APPROPRIATE
FUNDS FOR REPLACEMENT OF GATEWAY SIGNS ON
HOOPER ROAD & JOOR ROAD AND TO PROVIDE FOR
RELATED MATTERS**

WHEREAS, the Council and the Mayor of the City of Central desires to replace damaged gateway signs located on Joor Road and Hooper Road; and

WHEREAS, the cost of replacing the gateway signs is estimated at \$19,000;

WHEREAS, the Council did not include funding for the replacement of the gateway signs within the Half Cent Fund in the 2015-16 Budget;

WHEREAS, the Council for the City of Central desires to amend the 2015-2016 Fiscal Year Half Cent Budget to properly appropriate necessary funds related to the above stated matters.

NOW THEREFORE, BE IT ORDAINED by the Council of the City of Central, State of Louisiana as follows:

Section 1. Beautification (Half Cent Fund Account No. 120.431.99.730) is hereby increased by \$19,000.00 to provide for the expenditures related to the replacement of the gateway signs at Joor Road and Hooper Road..

Section 2. Conflicts

All ordinances or parts of ordinances in conflict with this Ordinance are hereby repealed.

Section 3. Severability

If any section, subsection, sentence, clause or provision of this Ordinance is declared by a court of competent jurisdiction to be invalid, such declaration of invalidity shall not affect the validity of the Ordinance as a whole, or parts thereof, other than the part declared invalid. The remainder of the Ordinance shall not be affected by the declaration of invalidity and shall remain in force and effect.

Section 4. Effective Date

This Ordinance shall be effective upon publication.
