11 WHEREAS, Central Fire Protection District No. 4 of East Baton Rouge Parish was created  
12 pursuant to Louisiana Constitution Article VI, Section 19 and Chapter 7 of Title 40 of the  
13 Louisiana Revised States, by Resolution No. 12991 of the Metropolitan Council for the Parish of  
14 East Baton Rouge and City of Baton Rouge; and

15 WHEREAS, part of the City of Central is located in Central Fire Protection District  
16 Number 4 of East Baton Rouge Parish; and

17 WHEREAS, the Central Fire Protection District Number 4 is governed by a five member  
18 Board of Commissioners, two of which are appointed by the Council for the City of Central;

19 WHEREAS, Kevin Rogers and Whitney "Chuck" Langlois, residents of Central Fire  
20 Protection District Number 4 of East Baton Rouge Parish were appointed by the Council for the  
21 City of Central and currently serve on the Board of Commissioners for Central Fire Protection  
22 District Number 4 of East Baton Rouge Parish; and

23 WHEREAS, the Mayor and Council for the City of Central desire to re-appoint Kevin  
24 Rogers and Whitney ("Chuck") Langlois as members of the Board of Commissioners of Central  
25 Fire Protection District Number 4 of East Baton Rouge Parish.

26 NOW THEREFORE, BE IT RESOLVED by the Council for the City of Central that Kevin  
27 Rogers previously appointed by Resolution No. 2012-2 and Whitney ("Chuck") Langlois  
28 previously appointed by Resolution Nos. 2009-05, 2010-04 and 2012-02 are hereby reappointed  
29 as a members of the Board of Commissioners for Central Fire Protection District Number 4 of East  
30 Baton Rouge Parish.
