CERTIFICATION REGARDING THE USE OF THE 2%
SALES TAX FOR ROAD AND STREET PURPOSES OF
THE CITY OF CENTRAL

TO THE

PARISH OF EAST BATON ROUGE, STATE OF LOUISIANA

I, I.M. Shelton, Jr, Mayor of the City of Central (the "City"), do hereby certify on behalf of the City and the governing authority of the City, that proceeds of the one-half of one percent (2%) sales and use tax (the "Tax") levied and collected in the Parish of East Baton Rouge (the "Parish") exclusively for road and street purposes and approved by the voters in the Parish on October 15, 2005, in the amount of \$1,164,761.90 (representing collections of the Tax within the boundaries of the City in calendar year July 1, 2014 – June 30, 2015), have been received by the City.

Furthermore, I hereby certify on behalf of the City and the governing authority of the City that the proceeds of the Tax received by the City will be used as follows:

- (1) \$ 50,386.45 of the proceeds of the Tax will be used for the construction of new public roads and streets (or the widening thereof), all as more specifically set forth and described in Exhibit A;
- (2) \$ 0.00 of the proceeds of the Tax will be used for the repair and improvement of public roads and streets, all as more specifically set forth and described in Exhibit B; and
- (3) \$ 50.86 of the proceeds of the Tax will be used for beautification projects, all as more specifically set forth and described in Exhibit C.
